Better Normal Flex Model

Our working hours are 36.5 hours, 7.5 hours a day (6.5 on a Friday), with core hours 10.30-4.30 Monday to Friday, (unless you are part-time) with a mix of studio and home working. 3 days per week in the Studio if you are full time (average of 50%). Each team has two team days per week when everyone in your team co-habits the studio workspace. Your studio days should be spread across the working week.

Enjoying Communities Near & Far!

Annual Leave

In addition to statutory bank holidays, you can enjoy 26 days annual leave inclusive of 3 days over the Christmas and New Year period when our studios are closed (Pro rata if you're part time).

Extra Holidays

After **3** years of working together, you can enjoy an extra day holiday entitlement. After 5 years, you can enjoy yet another extra day holiday entitlement.

Buying and Selling Holidays

As part of our Better Normal we will be giving you the opportunity to buy and sell leave.

- Option to buy a maximum of 5 days per year (pro rata for P/T).
- Option to sell a maximum of 5 days per year (confirm in the first 3 months of the year)

Creating a Sabbatical Pot

For you to bank holidays over 3 years for a 1-month long sabbatical in year 4.

- Year 1 Bank 5 days;
- Year 2 Bank 5 days;
- Year 3 Bank 5 days; and
- Year 4 Take 1 month paid sabbatical.

Request in advance giving a minimum of 6 months' notice.

Helping Communities Near & Far!

Volunteering Leave

- 2 days paid leave per annum for volunteering activities in the UK
- or 1 week overseas paid leave for volunteering activities linked to a recognised registered charity.

It's an opportunity for you to give something back to a community that you live in, work near, or have a passion to help. It could be charity work, helping at a community centre, getting involved with a community project, or working in a school.

It could also be an overseas charity that you have ties with. Rather than taking leave from your annual holiday entitlement you can take a certain amount of paid 'Volunteering Leave' per annum.

Enterprise Car Club

If you have a driving licence you can sign up to Enterprise Car Club to use in your spare time – there are vans and cars in convenient locations, some electric models are available and you just pay by the hour.
